Director's Message

In 1980, the Ventura County Office of Education (VCOE) established Gateway Community School. Located in Camarillo, Gateway serves school districts throughout Ventura County. Youth enrolled at Gateway (grades 6-12) are considered high-risk and referred to Gateway based on their current status with their home district, probation, and/or the School Attendance Review Board. Reasons for referrals typically include expulsion, chronic truancy, and severe behavior challenges. Approximately 10% of Gateway students transfer between Providence Court School and Gateway Community School.

Gateway works to prepare students to be respectful, positive, productive, and proud young people. This is a commitment that Gateway has made to its students, parents and school districts. We emphasize to all of our students that regardless of what city they live in, Gateway is everyone's community. Gateway Community School staff works collaboratively with students, parents, local public-school districts, Ventura County Probation Agency, and other outside community agencies to provide Gateway students a renewed sense of educational purpose through high expectations and social and emotional support.

2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

The governing board desires that the county office instructional materials, as a whole, present a broad spectrum of knowledge and viewpoints, reflect the diversity of our society, and enhance the use of multiple teaching strategies and technologies. Individuals who participate in selecting and evaluating instructional materials shall not have a conflict of interest in the materials being reviewed, as defined in Administrative Regulation. Complaints concerning instructional materials shall be handled in accordance with law, board policy, and Administrative Regulation 1312.2.

The Gateway Community School has 8 permanent classrooms and 2 portable classrooms. There are sufficient classroom, grounds, and staff spaces to support teaching and learning. The school is kept clean and in good repair at all times. The Ventura County Office of Education (property owner) provides ongoing custodial and maintenance support for the Gateway Community School.

In addition to staff supervision, the Court and Community School sites have perimeter fencing and video surveillance to keep the students safe on the school grounds. All classrooms contain all of the elements necessary for instruction including smart technology interactive surfaces, student computers, and staff workstations. Students and staff were dutifully involved with their instruction at the time of the site review.

All VCOE Court and Community School sites are currently in exemplary condition.

All parents attend a one-hour orientation prior to enrolling their child. The induction/transition specialist facilitates this orientation. Its purpose is to explain the academic program and behavioral expectations. In addition, parents and/or guardians complete required enrollment documents. The orientation is also an opportunity to invite parents to participate in their student's educational process.

It is Gateway's intent to facilitate the active engagement of parents beyond the more routine meetings held for attendance and behavior issues. Professional Development

Professional Development

A professional development plan aligned with the Elementary and Secondary Education Act and in support of the priorities in the VCOE Local Control and Accountability Plan has been developed by the VCOE Court and Community Schools. This plan ensures that each learning opportunity for department personnel contains the following elements:

1. Is an integral part of a broad school-wide and department-wide educational involvement plan

2. Is of high-quality and of sustained, intensive, and classroom-focused nature, so as to have a positive and lasting impact on classroom instruction and teacher performance in the classroom
3. Is aligned and directly related to state academic content standards
4. Is regularly and systematically evaluated for impact on increased teacher effectiveness and improved student achievement

In accomplishing the above, all professional development activities are grounded in scientifically-based research.

All Gateway staff members participate in 12 minimum-day trainings. Staff participates in training on the use of adopted and supplemental curriculum with a focus on English language arts, English language development, social studies, science, mathematics, and health. The curriculum is student-centered and standards-based with an emphasis on increasing access to the California State Standards for all students, including English learners, students with disabilities, foster youth, and socioeconomically disadvantaged students.

Training also focuses on providing behavioral and social interventions for at-risk students, the use of technology in the classroom, CPR, first aid, Nonviolent Crisis Intervention (strategies including those to prevent and break up fights), Threat Assessment, Trauma-Informed Care, Restorative Practices, Suicide Prevention and School Safety/Active Shooter response. In addition, staff participates in training specifically focusing on drug use intervention and prevention.

Also, a special emphasis has been made to bring staff together to collaborate in content specific departments to develop pacing guides, share ideas, lesson plans, materials, and strategies. Staff are provided on-going training in use of technology including Securly, Zoom, Google Classroom, Google Suite and strategies to engage students.
