Section 1003 of the ESSA provides grants to local educational agencies (LEAs) to serve schools implementing comprehensive support and improvement (CSI) activities. Apportionments for each grant performance period are based on cumulative expenditures less prior cumulative payments, not to exceed each LEAs allocation.
