#### L. DISCUSSION/INFORMATION/ACTION

1. <u>Submission of Charter Petition Renewal for Ventura Charter School of Global Arts and Education (Ventura Charter School) and Review of the Annual Programmatic Audit Presentation by Ventura Charter School – INFORMATION / DISCUSSION / ACTION (45 minutes)</u>

On April 13, 2006, the Ventura County Board of Education approved the charter petition for Ventura Charter School of Global Arts and Education. On January 10, 2011, the Board approved the renewal of Ventura Charter School. The term of the renewal charter expires in June, 2015, and Ventura Charter School has presented its request for renewal for the Board's consideration. As part of the VCOE's oversight responsibilities, staff has completed its review and collection of relevant data and the corresponding Monitoring and Oversight Report for Ventura Charter School, along with a copy of Education Codes 47605, 47607 (a) (b), and 47607.5 regarding charter school renewals, are included in the explanatory material.

In addition, in accordance with the VCOE Charter School Progress Report Timeline, representatives from Ventura Charter School will present information required in the annual programmatic audit detailed in the Memorandum of Understanding.

Following this meeting's presentation of the Charter School Monitoring and Oversight Report for Ventura Charter School, the Board may choose to deny or approve the renewal of the Ventura Charter School renewal petition or delay action until February 22, 2016, due to the voluminous nature of the data collected.
